(I)ELIGIBILITY CRITERIA FOR THE BIDDER

Scanned copies of the following documents are to be enclosed with the Online bid .

- 1.Bidders should have at least 3 yrs. experience in the relevant field of displaying advertisements on the bus bodies of STUs. Supporting papers to be uploaded.
- 2.An Application fees of Rs.1000.00(Rupees One thousand) only, in the form of Demand Draft, favouring South Bengal State Transport Corporation, payable at Durgapur, to be submitted. Scanned copy of the same to be uploaded.
3. Bidders should also submit a Demand draft of Rs. 25000.00(Rupees Twenty Five Thousand)only,as earnest money favouring South Bengal State Transport Corporation, payable at Durgapur. The said amount will be adjusted with the 1st Qtrly. Rental charge of the successful bidder. The said amount will be refunded to the unsuccessful bidder within one month from the date of closing of Tender.
- 4.The succesful bidders should agree to submit a Bank Guarantee which should be equal to the value of the rental charge of a quarter.
- 6.Bidders should submit the copy of PAN card, Trade Licence, Tax returns(e.g IT, Service tax etc.) for last three years
- 7.Bidders should give consent for entering into an Agreement with the Corporation regarding the tems and conditions to be imposed later on. Consent letter should be enclosed/ uploaded.
