TENDER NOTICE

SUB : Engagement as Selling Agent

Application are invited from bonafide Agency of SBSTC for engagement of Selling Agent to sale SBSTC bus tickets on JNNURM / Standard Buses on following terms & conditions.

- 1) Authorized Agency will furnish a list of such selling agents to the Depot-in-Charges/Depot managers of concerned Depots. Proper Identity card duly signed by Authorized Agency and uniform is to be provided to each of the selling agents deployed by Authorized Agency.
- 2) Selling Agents will have to deposit minimum **Rs. 550/-** per vehicle per day to SBSTC, well in advance prior to allotment of vehicle. On receipt of such deposit the vehicles will be allowed to the authorized selling agents by the Depot Authority .
- 3) Selling agents will arrange for providing HSD for operation of vehicles. Lubricants as required will be supplied by SBSTC.
- 4) Authorized Agency is authorized to receive Electronic Ticket Vending Machines from SBSTC on behalf of the selling agents against each vehicles on refundable security deposit of **Rs.15000/-** per machine. The security deposit will be forfeited in case of any loss or damage of the machine. Authorized Agency is permitted to allot the ticket vending machines to the selling agents to book passengers in the buses In case of cancellation of this engagement the ticket vending machines are to be returned to SBSTC falling which Rs. 15000/- per machine will be recovered from Authorized Agency.
- 5) Authorized Agency will run the vehicles at the prescribed route as specified by SBSTC and fare to be charged at the rate as per Govt. notification.
- 6) In case of non supply or breakdown of vehicle amount paid in advance will be adjusted. Depot-in-Charge / Depot Managers of concerned Depots is Authorised to take decision in this respect. However Tyre puncture in any case will not be considered as a case of break down.
- 7) Vehicles with Driver will be provided by SBSTC. Maintenance of the buses will be done by SBSTC.
- 8) The vehicles are to be parked inside our depot premises at concerned Depots after completion of scheduled trips daily.
- 9) Vehicles can't be utilized for other purposes like reservation / chartered trips etc.
- 10) Insurance charges against each vehicle will be borne by SBSTC.

- 11) Rate now fixed may be revised from time to time considering route survey and on mutual discussion with Authorized Agency.
- 12) SBSTC reserves the right to include or delete or revise the terms and conditions from time to time as per directive of Competent Authority.
- 13) SBSTC reserves the right to cancel the engagement any time without assigning any reason thereof.
