Tender for selection of Daily maintenance contractor of S.B.S.T.C, Howrah Depot

Sealed tender is invited by SBSTC for Howrah Depot from bidders having minimum three years experience of working in a State Transport Corporation or any government organization as Maintenance Contractor. They should have valid contractor's labour license issued by Government of West Bengal. They should be registered under E.S.I and P.F and should have a valid Reg. No. The last Date for submission of tender is 15/01/2016 up to 15hrs and the same will be opened in presence of bidders at 16hrs on the same day.

Terms and Condition

- 1) The technical personnel to be deployed at SBSTC, Howrah Depot.
 - a) Skilled workers:-18
 - b) Semi Skilled Workers:-9
 - c) Un skilled workers:-12
 - d) Supervisors:-2
- 2) Total Fleet of buses to be maintained:-53
- 3) Datum Level km in a month: 375916km
- 4) All daily, preventive and predictive maintenance with repairing of the buses has to be carried out in consultation with authorized personnel of SBSTC in order to achieve datum level kilometre.
- 5) The tools and tackles required for maintenance of buses has to be provided by Maintenance Contractor.
- 6) SBSTC will provide only machines like air compressor, welding machine, bench drill etc. The machines provided by SBSTC has to be maintained by the mechanical contractor.
- 7) Spare parts required for repair and maintenance of buses and equipments will be provided by SBSTC.
- 8) Maintenance Contractor will provide washing powder, old cloth and shampoo for washing of buses.
- 9) In case of brake down of buses on route, the same has to be attended by personnel's of Maintenance Contractor and repaired without fail.
- 10) Corporation reserves the right to reject any or all bidders without citing any reason.

- 11) Rate of commission per effective km operation has to be quoted in sealed tender.
- 12) Maintenance Contractor has to pay minimum wages to the technical personnel's employed for maintenance under him as per government of West Bengal, Labour departments circular. On revision of the wages by Government the same will be upgraded by SBSTC.
- 13) Maintenance Contractor will get full labour payment if datum level km is achieved otherwise he will be penalized @Rs 2/- per km for the shortage of km w.r.t datum level km if fault is on the part of Maintenance Contractor. The Datum level km will be upgraded time to time.
- 14) If it is found that Maintenance Contractor is violating the statutory liabilities of the workers his contract will be cancelled forthwith.
- 15) Maintenance Contractor will have to furnish a bank guarantee for an amount of Rs 500000/- which will be held as performance guarantee for sixty days after expiry of the contract.
- 16) Maintenance Contractor has to come into an agreement with SBSTC furnishing the detailed terms and condition.
- 17) Bidders are required to indicate the break-up of duties and taxes payable by them in the price schedule.
- 18) Total bill payable will be: - Effective km run per month * commission per km + labour charges including employer + employee contribution of P.F&E.S.I and bonus (-) duties and taxes.
- 19) Authority without prejudice can make amendments and/or modifications in contract in writing in mutual agreement with the contractor and the record of any such change shall be duly appended to the main contract document forthwith and be read as part of the contract.
- 20) Any damage to the bus due to mishandling by the Mechanical Contractor has to be compensated in full.
- 21) The Chairman, SBSTC, will act as the Arbitrator in case of any disputes. The jurisdiction will be at Durgapur.
- 22) The bidder shall be solely responsible for the payment of sales Tax and other taxes, if any levied by the Government and other local bodies
- 23) During evaluation of bids, SBSTC may, at its discretion, ask the bidder for clarification of his bid.
- 24) SBSTC, reserves the right at the time of award of contract to increase or decrease the quantity of goods and services originally specified in the schedule of requirements without any change in unit price or other terms and condition
