TECHNICAL BID

(I) ELIGIBILITY CRITERIA FOR THE BIDDER

Scanned copies of the following documents are to be enclosed with the Online bid .

- 1.** Bidders should have at least 3 yrs. experience in the relevant field printing of tickets of buses run by STUs. Necessary documents to be uploaded.
- 2.** Bidders should submit the copy of PAN card, Trade Licence, Tax returns (e.g IT, Service tax etc.) for last three years
- 3.** Bidders should enclose a declaration regarding uninterrupted supply of tickets as and when required and also a declaration ensuring the security of their printing press and materials.
- 9.** Hard copies of the relevant documents to be submitted in the tender box kept in the office of the Managing Director, South Bengal State Transport Corporation, Dr. B.C. Roy Avenue, Durgapur-713201.
- 10.** The rates must be quoted by the bidders clearly. There should not be any ambiguity. Rate of VAT must be quoted clearly.
