TECHNICAL BID

(I) ELIGIBILITY CRITERIA FOR THE BIDDER

Copies of the following documents are to be enclosed with the technical bid

1. Bidder should have necessary infrastructure of Bus Body Building Plants. Supporting paper to be enclosed.
2. Bidder should have experience of undertaking fabrication of new bus body construction & renovation job of buses of different state transport undertaking in West Bengal for 3 years. Supporting paper to be uploaded.
3. Bidder should submit the Copy of 1) PAN Card 2) Trade License 3) Income Tax Return for last 3 years 4) VAT Certificate 5) Insurance coverage of their Workshop premises.
4. An application fees of Rs. 5,000.00 (Five thousand) non refundable in the form of Demand Draft in favour of South Bengal State Transport Corporation to be submitted. Scan Copy of the same to be uploaded.
5. Parties should submit a declaration of furnishing Bank Guarantee to an extent of 10% of the Work Order Value (excluding VAT) in case the job is assigned to them. The Bank Guarantee

will be kept withheld for a period of 1 year from the date of delivery of renovated bus as performance guarantee and will be released on satisfactory performance.

6. Bidder should ensure safe custody of the vehicles while undertaking the extensive renovation of bus. Necessary declaration of the same to be uploaded.
7. Payment Terms:-On receipt of renovated bus, bills and bank guarantee (10%). 100% payment will be made after completion of all the formalities.
8. Bidder should submit no deviation certificate from the Specification as prescribed by the Corporation.
9. Bidder should mention no. of Bus Bodies they can renovate in 60 working days.
10. The hard copies of DRAFT should be submitted to the office of The Works-in-Charge, South Bengal State Transport Corporation, Dr. B. C. Roy Avenue, Durgapur, 713201 by 14.00hrs. On 04.04.2017.

(II) GENERAL TERMS & CONDITIONS FOR THE BIDDER

1. Tender should be in the prescribed format obtained online from the e-tender portal www.wbtenders.gov.in and it should be submitted as per the instruction given in para (IV) of this tender document.
2. SBSTC does not take any responsibility for the delay caused due to non availability of Internet connection ,Internet traffic jam etc. for online bids.
3. SBSTC reserves the right either to accept or reject any or all the tenders at any time. Corporation reserves the right to choose the bidder from successful bidders based on rate, credential, performance etc. For successful bidder whose product/service has not been used by the Corporation, trial order may be placed followed by formal order subject to satisfactory performance report.
5. The successful bidder shall be intimated of his selection for the award of contract. Hence no enquiry in this regard will be encouraged.
6. The rates quoted in the Financial Bid shall be inclusive of all Duties, levied by the appropriate authorities, CST / Vat should be mentioned separately. The bus body manufacturers should quote their rate for bus body renovation including supply of materials, scrap deduction and labour as one Unit. +V.A.T.
7. The rate quoted in the Financial Bid shall be valid for the period of 01 year from the date of opening of Financial Bid.
- 8) Corporation might extend the last date of submission of tender. This if done, will only be intimated in the Website: www.sbstc.co.in. and e-tender portal www.wbtenders.gov.in The extension, addendum or dedendum will not be published further in newspapers. Prospective bidders have to go through the website for information.
9. The bidder shall be solely responsible for the payment of sales Tax and other taxes, if any levied by the Government and other local bodies.

10. In exceptional circumstances, SBSTC may solicit the bidders consent to an extension of the period of validity. The request and the responses thereto shall be made in writing (or by e-mail or fax).
11. Online Bid must be submitted not later than the specified time & date.
12. The SBSTC may, at its discretion, extend the deadline for submission of bids by amending the bid documents.
13. During evaluation of Technical bids, SBSTC may, at its discretion, ask the bidder for clarification of his bid.
14. SBSTC will scrutinize the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed, and whether the bids are generally in order.
15. SBSTC, reserves the right at the time of award of contract to increase or decrease the quantity of goods originally specified in the schedule of requirements without any change in unit price or other terms and conditions.
16. SBSTC reserves the right to place order to the successful bidder/bidders as per its discretion.
17. The Managing Director, SBSTC, will act as the Arbitrator in case of any disputes. The jurisdiction will be at Durgapur.
18. Delivery of renovated bus with penal Late delivery clause:- The bus after renovation should be delivered before 60 working days from the subsequent day of receipt of the bus for job. Late delivery to the tune of Rs500/-(rupees five hundred) will be charged per day for each day of late delivery exceeding 60(sixty) working days. Working days exclude Sundays and holidays(26th Jan,15th Aug,2nd Oct,1st May,Mahalaya,Fatehaduazdahum,Id-ur-Zuha,Austami,Dashami,muharram,Kalipuja,Id-ul-Fitar,Saraswati Puja,15th April,Doljatra&25th Dec.)
19. Payment Terms: - Payment will be done as per clause 7 of Para-I. against submission of relevant papers.
20. The taxes and duties will be applicable as prevailing at the time of delivery.
21. Financial bid of only those bidders will be opened who are found to have fulfilled all the criteria as specified in Technical bid (Para-I).
22. Price BID/BOQ (Financial bid)
“Financial Bid” shall contain the financial bids with the base rate per accounting inclusive of transportation, installation charges, freight charges, VAT, Excise duty and entry tax (wherever applicable) to be quoted. Bidders are required to fill online only in the BOQ Folder, further bidders are required to explain the taxes/levies etc. as mentioned in the Price Bid and upload a scan copy of write ups on taxes/levies etc in the Misc Folder.

SCOPE OF WORK (FOR EXTENSIVE RENOVATION)

1. Opening of all the external, internal panels along with front & rear show to re-fabricate for new look. Change all the external panels with 18swg new Al panels and covers with 18swg Al sheet. Interior roof panel to be fitted with new ACP panel.
2. Under chassis servicing of bus to be done along with under chassis and structure painting after changing of structural angles where required.
3. The sliding windows along with fixed glass to be opened out, repaired and refitted
4. All roof domes & outside roof panels to be changed where damaged.
5. Change all decoration moulds with new ones.
6. Change all accident bits with new heavy Volvo bit.
7. Change all water channels with new ones
8. Repair of battery box to be done with repair of rear luggage carrier.
9. New Thermocol insulation to be used in the roof and side panels in order to reduce heat transmission.
10. Chequered plate to be opened for repairing of floor structure.
11. New front windscreen, two part safety glass /triplex glass to be fitted.
12. New curtains to be fitted inside the vehicle.
13. Deluxe type seat to be newly fabricated and fitted in the bus.
14. Internal decoration to be done,
15. P.U metallic paint to be painted in the outside bus body as specified.
16. Decorative L.E.D lights 10 nos. to be fitted inside the saloon. New wiring of Lucas or equivalent makes to be fitted. Special Headlights to be newly fitted. Wiper wheel box, sidelight assemblies, tail light assembly, flasher units, top indicator light, 2nos. Fog light assembly, electric horn, and wiper arm, wiper blades, battery cut-off switch to be newly fitted. All the battery cable to be newly fitted.
17. New audio system with speakers to be fitted equivalent to Ahuja or Sony makes.
18. The newly fitted floor of the saloon to be covered with Pvc mats
19. Front and rear bumpers to be newly made
20. Roof tar felt to be fitted and leakage of water from roof to be prevented.
21. All the door locks to be replaced with new heavy duty locks. Rear view mirrors (big) to be fitted in the deluxe bus.
22. Front Show, battery box, Rear dickey to be fitted with heavy duty ambassador dickey stand.
23. All the rubber channels to be newly fitted.
24. All kind of Dickey shocker to be changed by good quality.
25. All dickey lid chain type hinges must be changed/newly fitted.
26. Bus body writing to be written in Artistic style.
27. All Body U-bolts to be changed with new balata packing.
