Sub: Engagement of full franchise operator
Ref:-Your letter dated -19/7/2017

In inviting a reference to the above, you are hereby engaged as " Full Franchise operator" for one standard bus of this Corporation to operate bus services in the route **Shyambazar to Burdwan** subject to your fulfillment of the following terms and conditions:-

- 1) The engagement as Full franchise operator will be for an initial period of 6(six) months from the date of engagement which may be renewed from time to time considering his performance as per decision of the Corporation. Corporation retains the right to terminate the contract any time without assigning any reason.
- 2) The bus shall be plied in the specified purpose and cannot be utilized for other purposes.
- 3) The party will pay Rs. 13,000/- monthly rate as franchise charge to be deposited in advance in Durgapur Divisional Office well in advance in every month.
- 4) Before starting of operation, the party will have to security deposit of Rs 25,000/- .
- 5) Normally the bus shall be parked at SBSTC depot premises after completion of operation.
- 6) SBSTC will provide only bus. The party will arrange required HSD and engine oil on his own cost. The party will bear the cost of insurance.
- 7) Party has to engage required no. of man power for plying the bus who should have valid license as per M.V. Act. 1988.
- 8) The cost of maintenance of the vehicle will be borne by the SBSTC. The repairing jobs will be done at Burdwan depot of SBSTC.

- 9) The workers engaged by the party will have no right to claim any employment from the Corporation in future.
- 10) The employees engaged by the party must be paid wages which should not be less than minimum wages. They are also to arrange for coverage of their employees under PF and ESI at their own cost.
- 11) The Corporation shall not bear any expenditure on account of any accident/ injury sustained by employees of the party arising out of and during the course of employment.
- 12) In case of B/D of the vehicle or non-operation of the service for any incident like bandh, obstruction, accident etc., normally no concession will be allowed in the payment of franchise charge.
- 13) Party shall have to execute an agreement with SBSTC in non-judicial stamp worth Rs. 10/- within one week formulating further details of terms and conditions.


