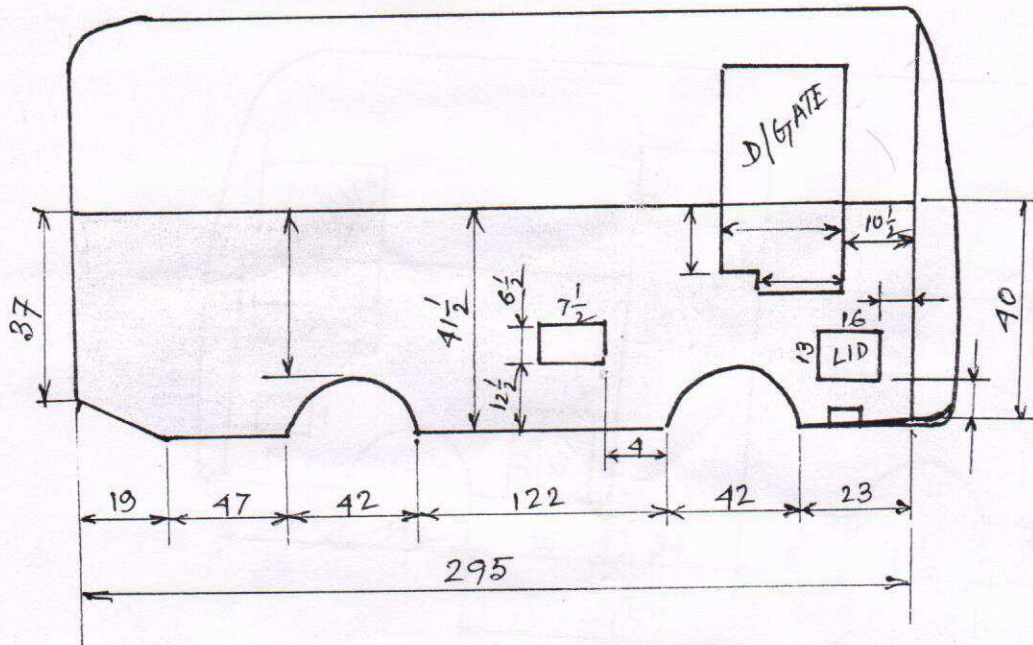

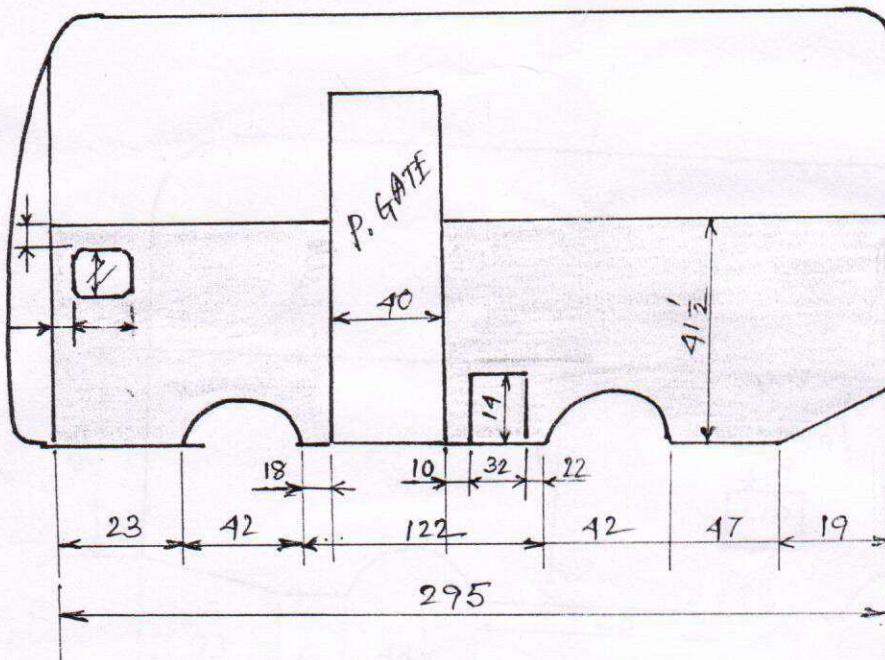

RIGHT SIDE PANEL

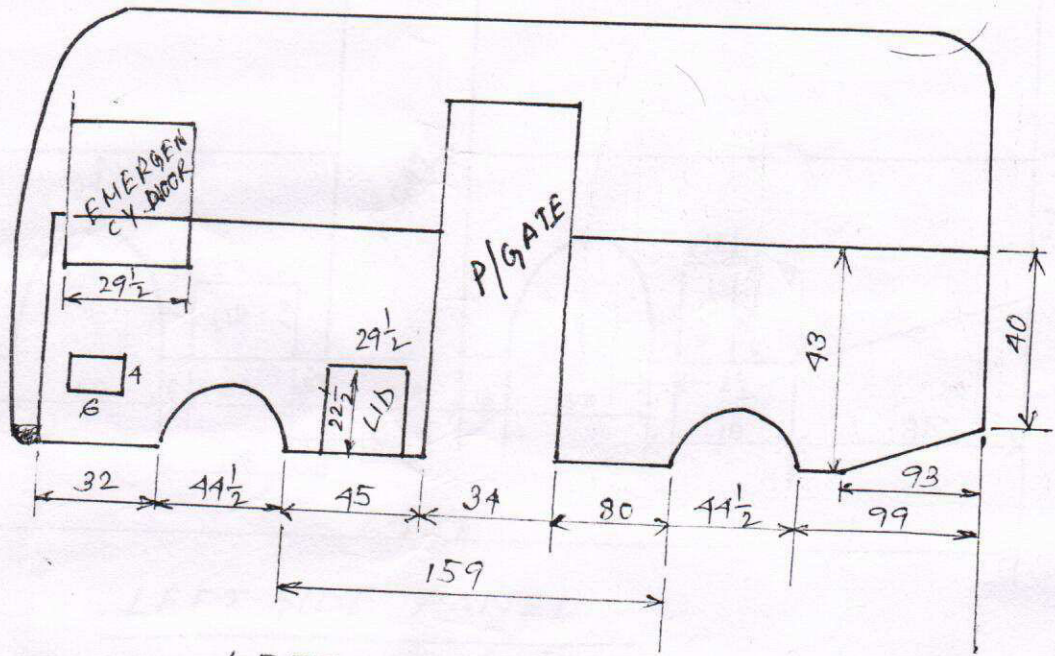

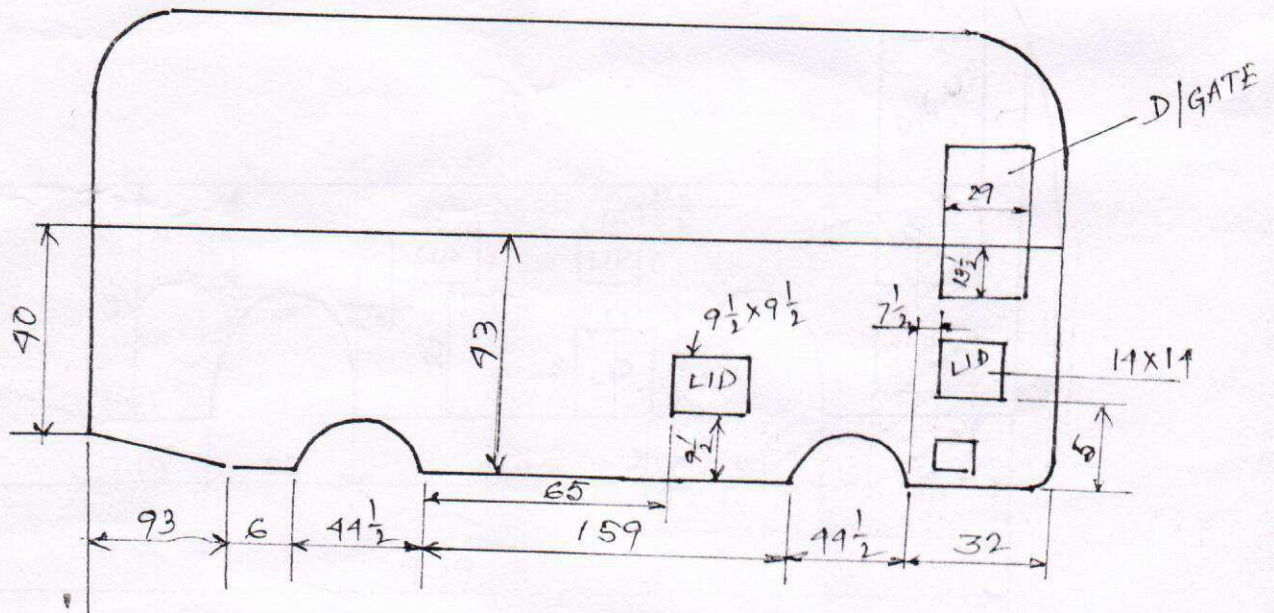
