Complete filled up application form in a sealed envelope super scribed with 'Franchisee for service' and 'tender notice no. DTO- (28) SBSTC/18 dated- /2018 must be attached with money receipt or A/c payee bank draft of Rs.1000/- in favour of SBSTC payable at Durgapur which may be dropped at tender box in Durgapur Head Quarter. The last date of submission for sealed quotation is **04/09/2018** up to 12.00 hrs. with all related papers which will be opened at 12.30hrs. on 04/09/2018 at Durgapur H.Q. The tenderer may remain present at the time of opening.

Terms & Conditions.

1. The Corporation reserves the right to reject any/ all tenders without assigning the reason what so ever.
2. The engagement as franchisee will be for an initial period of one (1) year from the date of agreement which may be renewed from time to time considering his performance as per decision of the Corporation however accrue upon for further continuity of such agency. Corporation retains the right to terminate the contract any time without assigning any reason.
3. Franchisee will be provided with the fare chart to abide by of Govt. rate on the basis of which the fare is to be collected. He has to ply the vehicle as per the prescribed time-table of the Corporation.
4. Franchisee will pay the quoted rate in tender per bus per month as franchise fee and Rs..... as security money.

5. Franchisee will have to deposit at least three (3) months agreed amount in advance before placing the bus on route and thereafter payment will be made by 10th instant of the respective calendar month.
6. The Corporation shall allow the franchisee to use Logo & Brand name to be embossed in their own buses.
7. The franchisee will provide vehicle, crew and others. Corporation will provide only the route permit. The cost of maintenance of the vehicle will be borne by the party.
8. The Corporation shall not bear any responsibility for any accident/ incident if occurred and any responsibility of employment in future of the crew or any other staff engaged by franchisee for the same.
9. The franchisee will bear the cost of insurance premium and a copy of insurance with details of crew will be submitted to SBSTC office before deploying the bus.
10. The franchisees are authorized to use the depot/terminus infrastructure of the STU nearest to the route for parking and operation of the buses.
11. An agreement will have to be made within ten (10) days with SBSTC after getting the offer letter.
12. The franchisee will have to own and place buses of the type mentioned in the EOI for the route selected within 60 days of signing the agreement.
13. The franchisee will not be engaged any sub agent/sub franchisee.
14. Bus shall not be used by the franchisee for any purpose other than that as mentioned in the permit and agreement.
