CIRCULAR

Sub: Online Submission of 'Joint Option Form' under erstwhile proviso to Para 11 (3) of Employees Pension Scheme, 1995 as per direction of Hon'ble Supreme Court Judgment dated 04th November, 2022.

1. A circular vide no. 174/AC/SBSTC/2023-24 dated 22/06/2023 has already been issued in the official website of this office (www.sbstc.co.in) to the ex-employees of SBSTC, who have retired or attained 58 years of age before 01.09.2014 for providing written refusal letter of APFC or higher authority of EPFO regarding joint option form submitted earlier under proviso to Para 11(3) of the EPS'95 for onward submission and necessary approval from the employer side of their respective application in the EPFO portal on or before 25-06-2023. As, no such desired documents not received from those respective ex-employees we have no other choice but to reject those application in the EPFO portal.

2. Now, EPFO, as a measure of principle of natural justice, have given an opportunity again to provide following documents for granting their application for Higher Pension, within thirty days of the issue of their letter, from the ex-employees (a copy of the same letter has also been provided by the EPFO to respective ex-employees in their email) as per details given in the table -1

- (i) Proof of joint option under Para 26(6) of the EPF Scheme duly verified by the employer
- (ii) Proof of remittance in Provident Fund on higher wages exceeding the prevalent wage ceiling of Rs.500/6500
- (ii) Proof of remittance in Pension Fund on higher wages exceeding the prevailing wage ceiling of Rs.5000/6500 if any
- (iv) Proof of Option u/p 11(3) prior to 26-Oct-2007
- (v) Written refusal of APFC or any other higher authority of EPFO to such request/remittance
