
**Terms & Conditions for hiring of Maxi-Cab (vehicles constructed or adapted to carry more than 6 passengers) with engine capacity less than or equal to 2000 C.C. (AC) :-**

- 1) The owner of the hired vehicle will get Rs. 525/- per day.
- 2) Monthly rate is for 10 hrs. a day and additional charge @ Rs. 20/- per hour beyond 10 hours in a day.
- 3) Fuel allowed is 1 liter for 10 km.
- 4) Mobil oil allowed @ 1 lit. for 500 km. run
- 5) The engagement will be for an initial period of **six months**, which may be extended time to time with the consent of both the parties (the SBSTC and the owner of the hired vehicle).
- 6) The engagement might be cancelled at any time with a prior intimation of one month from any of the parties (the SBSTC and the owner of the hired vehicle).
- 7) The owner of the hired vehicle shall not utilize the light vehicle in any other purpose excepting for the use of the SBSTC during of the period of work/agreement with the SBSTC.
