2. Bidders should also submit a Demand draft of Rs. 100000.00 (Rupees One Lakhs) only, as earnest money favouring South Bengal State Transport Corporation, payable at Durgapur. The said amount will be adjusted with the Qtrly. Rental charge of the successful bidder. The said amount will be refunded to the unsuccessful bidder within one month from the date of closing of e-tender.

3. The successful bidders should agree to submit a Bank Guarantee which should be equal to the value of the rental charge of a quarter.

4. Bidders should submit the copy of PAN card, Trade License, GSTN documents, Tax returns (e.g. IT, GST etc.) for last three years

5. Bidders should give consent for entering into an Agreement with the Corporation regarding the terms and conditions to be imposed later on. Consent letter should be enclosed/uploaded.

6. Bidders should enclose a declaration regarding uninterrupted payment of rental charges as per the Agreement.
