The successful bidder has to set up the Canteen at the specified Hall and make all arrangements for preparing tea, snacks & meal etc. and display the rates of all food items in the rate board which to be hanged in front of the Canteen. The Agency will be allowed to set up a Tea and Snacks stall adjacent the depot premises for use by the general public too. The electric and water supply to be made by the Corporation and a sub meter for electric connection shall be arranged by the Corporation. The electricity charge as per meter reading to be paid by the agency. He will arrange to provide oven, utensils etc. He will arrange to keep the Canteen area neat and clean and ensure the place be washed daily. He will ensure that the employees of the South Bengal State Transport Corporation will get subsidized rate of food items and also Canteen be run hygienically.

The interested agency may submit the rates for setting up and operating of Canteen at **Howrah Depot** in a sealed envelope along with Xerox copies of the required documents (self attested) in the Civil sec of Belgharia Divisional Office, South Bengal State Transport Corporation, 5/5 B.
